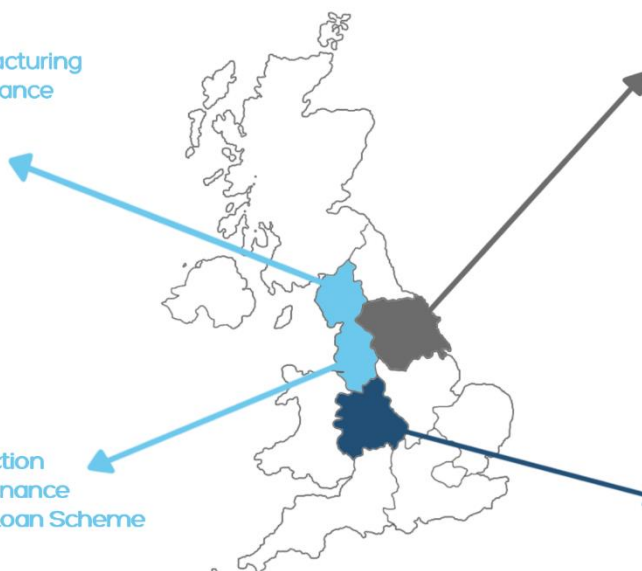

## Self-Assessment Tax

By midnight on 31st July 2022 business owners across the UK who pay tax through "payment on account" will have to have made their second payment relating to the tax year 2021/22.

2019

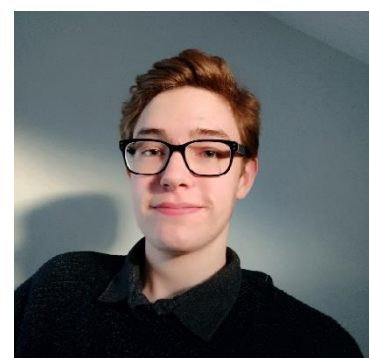
In 2019 Amiga Finance assisted in sourcing our largest unsecured funding amount of £315,000.

### Self-Assessment

Due 31<sup>st</sup> July – 2<sup>nd</sup> payment for the tax year 2021/2022
