## **Asset Finance**

#### Features and Benefits

- Spread the cost across a set period of fixed monthly instalments to smooth business cashflow
- Preserves capital / cashflow and existing arrangements
- Allows a business to fund almost any tangible business asset from as little as £5000
- Repayment terms available between 12 months and 84 months
- Usually more cost effective that other forms of borrowing

Within Asset Finance there are various styles of funding available depending upon the business' needs and the asset involved.


Hire / Lease Purchase - Straight forward asset funding that guarantees ownership at the end of the repayment term. VAT usually paid in advance, sometimes a VAT deferral is available.

**Finance Lease -** A finance lease allows the customer to use an asset rather than buy it with no ownership at the end. VAT is spread across the term

**Operating Lease -** A short-term lease where the asset is typically returned to the lender at the end of the contract. VAT is spread across the term

Refinance - Raising finance against equity that is locked in assets owned by the business
